Artist Prospectus and Agreement 2009

Funding and Proceeds:

- Artists can submit interior and exterior artwork of varying sizes.
- The artwork created for this project is a donation and will become available for purchase through a public auction on Thursday, September 17, 2009, benefiting the Omaha Symphony Guild.
- The artist will receive 30% of the selling/purchase price after the auction.
- If the Auctioneer determines that any opening bid is not commensurate with the value of the article offered, he may reject the sale and withdraw the article from sale; and if, having acknowledged an opening bid, he decides that any advance thereafter is not a sufficient amount, he may reject the advance.
- At the conclusion of the auction, all property shall be removed from the possession of the auction by the Purchaser, or the Purchaser shall make arrangements with Auction staff for delivery or shipment of purchased items to specified locations. A fee will be charged for delivery and placement of purchased artwork depending on size and location of the delivery. Purchaser is responsible for all shipping costs.

Physical and Design Requirements:

- All art media will be considered for acceptance. Once accepted, the artist is bound to the design concept submitted.
- The exterior works must be fabricated and installed in such a way that the installation will not impair the sidewalk use, leaving a minimum access of 36”.
- Existing Rockbrook Village® exteriors will not be changed or defaced in any way.
- There are no restrictions on the materials used by the artist doing outdoor sculptures except that the finished work should be suitable for remaining outside in all weather conditions. For all works, there should be nothing to climb on. The piece needs to endure the elements and stay in place during high wind conditions. The artist will ensure stability of their piece of art through design. No wall or cement sidewalk fasteners will be used. If the artwork is painted or stained, it must be done in a way that will not deface or run off onto sidewalk.
- The audience will be the general public of all ages. We encourage artists not to limit the theme of their submittals to music or the arts.

Installation:

- Artist will be responsible for installing the work by August 4, 2009. Artist will supply their own hardware, tools and labor needed in the installation of the work on site. Rockbrook Village® will provide supervision during the installation and removal process.

Liability and Damage:

- Rockbrook Village®, merchants, and organizers will not be held liable for any physical damage or loss of the artist’s work. The artist is responsible for coverage of goods through damage, theft, and/or acts of God. Proof of insurance will be provided by the artist. Proof of coverage must be submitted at time of agreement submittal.

Publicity:

- The Music & Masterpieces Committee will implement a multi-media publicity campaign, including, but not limited to, signage, radio and television advertising, newspaper, print, posters, maps, brochures, and internet.
- Artist agrees to allow Music & Masterpieces to photograph their work and use the photographs and artist’s name in any publicity.
- Artist agrees to be present for all press/preview events to the best of his/her abilities.
- Music & Masterpieces encourages artist to create reciprocal publicity through artist’s web-site, mailing lists, and other means of informing the public.
